

END-USER LICENSE AGREEMENT FOR BTK SOFTWARE (Pty) Ltd's Software namely "Poacher Down"

IMPORTANT PLEASE READ THE TERMS AND CONDITIONS OF THIS LICENSE AGREEMENT CAREFULLY BEFORE CONTINUING WITH THIS PROGRAM INSTALL: BTK Software's End-User License Agreement ("EULA") is a legal agreement between you (either an individual or a single entity) and BTK Software (Pty) Ltd. For BTK Software's software product(s) identified above which may include associated software components, media, printed materials, and "online" or electronic documentation ("SOFTWARE PRODUCT"). By installing, copying, or otherwise using the SOFTWARE PRODUCT, you agree to be bound by the terms of this EULA. This license agreement represents the entire agreement concerning the program between you and BTK Software (Pty) Ltd, (referred to as "licenser"), and it supersedes any prior proposal, representation, or understanding between the parties. 1. GRANT OF LICENSE.

(a) Installation and Use.
